# Linear perturbation of the Schwarzschild metric

### Preliminaries

#### Kernels for parallel evaluation

In the following we will represent tensor fields by arrays, i.e., nested lists. To reduce the time needed for simplification, we simplify their components in parallel. The following command launches several parallel kernels, corresponding to the number of available CPU cores.

#### Simplification to linear order

Since we are working with linear perturbations, which we define with respect to a perturbation parameter  $\epsilon$ , we discard all terms of higher than linear order, and then simplify.

We define the metric  $\gamma_{ab}$  in the angular coordinates ( $\chi$ ,  $\varphi$ ) we use.

We define the totally antisymmetric tensor on the sphere with a negative sign, since the coordinate frame in the ( $\chi$ ,  $\varphi$ ) has the opposite orientation compared to the standard ( $\vartheta$ ,  $\varphi$ ) coordinates, and we use the latter orientation.

## **Tensor harmonics**

#### Derivatives of spherical harmonics

Here we implement the rules for derivatives of the spherical harmonics Y<sub>lm</sub> by hand, since we use rather non-standard coordinates. These are defined by the Laplace equation and the usual angular dependence.

The scalar harmonics are simply the spherical harmonics themselves. They have polar parity.

#### **Calculate Laplacian**

It is instructive to calculate the Laplacian of the tensor harmonics, which is one possibility to define them (along with the action of the angular momentum operators).

## Spacetime geometry

#### **Background metric**

We proceed with the spacetime geometry. This is the unperturbed background metric. Here we assume a spherically symmetric, static metric, but we leave the  $g_{tt}$  and  $g_{rr}$  components as free functions of the radial coordinate for now.

#### Metric perturbation

We then define the metric perturbation.
